


# Written report of the IPEX Information Officer on the work of IPEX in 2019


In 2019, the implementation of the IPEX Digital Strategy and its Work Programme for 2017 - 2020 have entered a final stage. The working groups on Enhancing the IPEX Network, Promoting IPEX and Improving the IPEX Digital System either have finished or are closing in 2020 the activities of their Action Plans, with an eye on the future planning. This sustained activity of and progress achieved by the IPEX platform is thus fully reflected in the statistical data used in this report. Due to the European Elections of 2019, the number of proposals and scrutiny procedures have declined, while the number of users and pages visited have soared.

#### 1. Website statistics

In 2019, the IPEX website was visited by **342.355 unique visitors**, following the general progressive trend of the previous years (2018: 305.000; 2017: 307.737; 2016: 253.264). **The number of pages viewed although – almost 43, 1 million! – is the highest registered so far, an almost threefold increase over the 16 million pages reported for <b>2018** (2018: 15.939.723; 2017: 5.736.506; 2016: 6.012.105)!

The number of visits and pages accessed is telling for the way IPEX is being perceived and in line with the Conclusions of the 2018 Meeting of Secretaries General of the European Union Parliaments "acknowledging that IPEX is becoming a "one stop shop" for interparliamentary exchange on EU affairs and documents".

The addition of new subpages over the past years - COSAC, Inter-Parliamentary Conference for the Common Foreign and Security Policy and the Common Security and Defence Policy (CFSP/CSDP), Interparliamentary Conference on Stability, Economic Coordination and Governance in the European Union, Joint Parliamentary Scrutiny Group (JPSG) on the European Union Agency for Law Enforcement Cooperation (Europol) - has most probably added more traffic and brought more interest in interparliamentary cooperation and its formats in the EU.

# **Upload of documents and dossiers**

IPEX publishes currently **over 106.000 pages** from national parliaments and the European Union institutions, holding **scrutiny related information in almost 80.000 documents** produced by national Parliaments and linked to **some 12.000 dossiers**. In 2019, the total number of legislative and non-legislative documents recorded in IPEX, was **812** (2017: 1053; 2016: 1064; 2015: 805).


## **Documents and scrutiny updates from national Parliaments**

Related to the legislative proposals in 2019, national parliaments uploaded **3.397 scrutiny related** pages<sup>2</sup> (2018: 5.799: 2017: 3.588; 2016: 6.624).

## Number of dossiers added to the IPEX database<sup>3</sup>



The elections for the European Parliament of 2019 have slowed down the activity of the European Commission, while the European Parliament has come to a halt, a cyclical process observed also during the previous years, thus a certain decline in the number of scrutiny pages opened on IPEX. This could also be attributed, among other things, to the absolute premier of 2019 - no national Parliament or chamber have issued any reasoned opinion in 2019.



Also in 2019, the IPEX Twitter account #IPEXEU was launched during the Annual IPEX National Correspondents Meeting in Vienna. #IPEXEU is part of the Social Media Strategy of IPEX and it is focusing on accessing new communication areas and on raising the visibility profile of IPEX and national Parliaments in EU affairs.
